3.0 Officiating

3.1 With the exception of one game, officiating was consistent, and while no major problem existed. Unfortunately, in this one match the referee became the central figure of the game

4.0 Discipline

- 4.1 The trip started on the right foot. After we arrived we received an email from a Porter flight attendant who explained that the girls were very polite and were great ambassador for the province, and a pleasure to have on the plane.
- 4.2 Discipline on the field was an issue due to the fact that the organizers decided that they wanted to give the kids a chance to play and be evaluated and did not want them to be suspended in a short tournament.
- 4.3 For this Atlantic Tournament this is the Discipline that was administered:
 - a) Cautionable Offenses (yellow cards)
 - b) Accumulation of Yellow Cards throughout Round Robin = no suspension

- 4.4 For this Atlantic Tournament this was the Discipline that was administered. Dismissals (red cards)
 - 4.4.1 Violent Conduct = 1 game suspension + hearin
 - 4.4.2 Offensive, insulting, or abusive language or gestures = 1 game suspension + hearing
 - 4.4.3 Spitting at an opponent or another person = 1 game suspension + hearing
 - 4.4.4 Serious Foul Play = no suspension*
 - 4.4.5 Denying obvious goal scoring opportunity handball = no suspension
 - 4.4.6 Denying obvious goal scoring opportunity foul = no suspension
 - 4.4.7 2nd caution in same match = no suspension

5.0 Accommodations

5.1 Both teams stayed at Crowne Plaza in Moncton, NB. The rooms were clean and in good condition. It is a large hotel with all the amenities. The staff has always been very accommodating.

6.0 Transportation

6.1 Each Province is responsible for transportations for their teams.

9.0 Medical / Physio

9.1 Soccer NB will be providing Athletic Therapists / Physiotherapy for each game. Pre-Game Taping will be provided at the Physio room $-\frac{1}{2}$ hour before each game. Please supply your athletes with tape should they require taping services.

10.0 Administrative Services

- 10.1 The only services that were available was a limited supply in the hotel but it was adequate.
- **11.0** Security Security never seemed to be an issue.

12.0 Opening / Closing Ceremonies

- 12.1 Opening Ceremonies There were no opening ceremonies
- 12.2 Closing Ceremonies Small presentation at the field

13.0 Communications

13.1 Games were streamed and were made available to each team

- 13.2 Programme No program was available
- 13.3 Newsletter One was not available
- 13.4 Passes Available at the main gate at a cost of \$15 for a full tournament pass (16 Games) or \$5 for a day pass (4 Games per day)
- 14.0 Merchandise No merchandise was available

15.0 Weather – all games were played on turf

15.1 The weather was very hot with most games being played in 30-35 degree heat.

- **16.0** Laundry Services were available in the hotel.
- **17.0** Team Staff ID No Tournament IDs were available or required.

18.0 Tournament and Day Passes

18.1 Available at the main gate at a cost of \$15 for a full tournament pass or \$5 for a day pass.

19.0 Pre-Competitions Meeting

- 19.1 The pre-competition meeting will be held via zoom on Wednesday June 22nd at 8pm. The meeting will be chaired by a representative from Soccer NB. All Provincial Reps, Coaches or Managers must attend this meeting. Note: The (tentative) will change according to availability of each province.
- 19.2 Our teams did not mention that we would need to play the two earliest games on the final day to allow us to catch our flights.

20.0 Pre-Game

- 20.1 Games on day one was scheduled 90 minute apart, and the schedule went very far behind due to allowing long warmups. Games on the remining 3 days were provided with a 2 hour time frame.
- 20.2 All teams will have a minimum of 20 minutes on field warm up time.

21.0 Format

- 21.1 3 game round robin
- 21.2 Placement games will be 1 v 2 and 3 v 4
- 21.3 3 points for a win, 1 point for a tie
- 21.4 Games in round robin may end in a tie
- 21.5 Placement games that end in a tie will go directly to PK's according to FIFA
- 21.6 Games will be 2 X 35-minute halves
- 21.7 Size 5 ball supplied by Soccer NS
- 21.8 7 subs per game, unlimited at half time
- 22.0 Conclusion There were some very serious issues that need to be addressed:

- 22.1 Rules and Discipline We need to determine if we want to participate in tournaments which ignores the Canada Soccer Discipline Code and where yellow cards have no meaning.
- 22.2 Covid was an issue. We ran into a situation where a player tested positive, and as a result was released to the mother, who then assumed complete responsibility of the player including her transportation home.
- 22.3 The family was informed that the player cannot have any interaction with the team. Unfortunately, the family continued to attend games from a good distance. The family then attempted to gather in a greeting area where the plyers and parents waited for the bus to collect the girls. As a result, I had to remove the players from the situation.
- 22.4 We escaped a very contentious issue. In this situation, the parent was there. The question remains what if the parents were not at this tournament?
- 22.5 We need to have a policy to address this issue.
- 22.6 Finally, it should be noted that Younes was very accommodating to our requests.

TOURNAMENT RULES

Please note that all tournament rules are set by the Atlantic Technical Forum and are subject to review by that body.

Number of Players: MAXIMUM 20 on game sheet

Duration of Play: 2 x 40 minute halves

Substitutions: 7 during open play, unlimited at half time and re-entry is allowed

Coaching Staff: Teams will be allowed a maximum of 5 staff on the bench, all of which must be listed on the tournament credential form

Extra Time: No extra time will be played in any match. In the round robin, matches may end in a tie. Should any of the medal games be tied at the end of full time, the match will go directly to kicks from the mark, which will commence as per FIFA procedure.

Tie Breaking Procedure

Following FIFA Rule 18.6 of Competition, in the round robin format, the ranking in each group is determined as follows:

a) Greatest number of points obtained in all group matches;

- b) Goal difference in all group matches;
- c) Greatest number of goals scored in all group matches.

If two or more teams are equal on the basis of the above three criteria, their rankings shall be determined as follows:

- d) Greatest number of points obtained in the group matches between the teams concerned
- e) Goal difference resulting from the group matches between the teams concerned
- f) Greater number of goals scored in all group matches between the teams concerned
- g) g) Drawing of lots

Discipline Policy

The Atlantic Technical Forum has determined the following discipline policy after taking into consideration the principles of respect, fair play, player development, and player showcasing:

Cautionable Offenses (yellow cards) o Accumulation of 3 Yellow Cards throughout Round Robin = 1 game Suspension

Dismissals (red cards)

- 1) Serious Foul Play = 1 game suspension
- 2) Violent Conduct = 1 game suspension + hearing
- 3) Spitting at an opponent or another person = 1 game suspension + hearing
- 4) Denying obvious goal scoring opportunity handball = no suspension
- 5) Denying obvious goal scoring opportunity foul = no suspension
- 6) Offensive, insulting, or abusive language or gestures = 1 game suspension + hearing
- 7) 2nd caution in same match = no suspension, but does count as 2 yellows accumulation
