5.0 ACCOMMODATIONS

Sheraton Vancouver Guildford Hotel was used by all teams. This was a very nice hotel and did a great job hosting the teams. But some player rooms had one 1 bed plus a pull-out.

6.0 TRANSPORTATION

Buses from the airport to the hotel were good. Buses to and from the venue were good. But the LOC did not provide buses for teams that wanted to go watch other matches. Players really did not have any options to watch other matches.

On the final day, the timing of the buses, matches and hotel check out made it impossible for the girls team to watch any of the championship matches.

After the closing ceremony, PSC were given access to dressing room showers but this resulted in the team being at the field (with limited access to food) for over 8 hours (about 6 hrs after their match completed).

I understand the final day is complex but maybe the NLSA need to come up with a better solution for make this already very long day easier to manage.

7.0 FIELDS

Most matches played on Turf including all the NL matches. The fields were about 10 km or about 25 mins for the hotel. Teams had access to a changing room.

Social room for coaching staff was offered each night.
